Subject:- Setting up of 50 new Kendriya Vidyalayas under Civil / Defence Sector
all over the country during the year 2016-17 - reg.

Sir,

I am directed to say that the Competent Authority has approved the proposal contained in para-3 of the supplementary note regarding setting up of 50 new Kendriya Vidyalayas all over the country. The para-3 of the Supplementary note reads as under:-

"3. As the new KVs are proposed to be opened only in those locations where the State Governments / sponsoring authorities come forward and offer the land as well as provide temporary accommodation required for opening of the KV and also arrange for the transfer of land in favour of KVS, it is proposed that these new KVs can be opened under the **challenge mode**, whereby the sponsoring authorities who fulfil the norms of KVS within a specified time frame will be accorded priority on 'First come First served' basis and the sanctions utilized accordingly.

Approval of the CCEA is accordingly solicited for

- (i) For opening of 50 new Kendriya Vidyalayas under Civil / Defence sector at various locations as per approved norms of KVS with a financial allocation of Rs.1160 crores. The proposals from the sponsoring authorities in the lists at Annexure - I & Annexure - II would be considered under the challenge mode, whereby the sponsoring authorities who fulfil the norms of KVS within a specified time frame will be accorded priority on 'First come First served' basis., Administrative orders for opening of the KV would be issued by KVS only after transfer of requisite extent of land in favour of Kendriya Vidyalaya concerned.

(ii) For incurring an expenditure of Rs.104.77 crores during the 12th Plan with a spill - over of Rs.1055.23 crores during the period 2017-18 to 2019-20."

2. Copies of the Annexure - I & II referred to above are enclosed. KVS is accordingly advised to take appropriate follow up action and send regular updates to this Ministry on the status of implementation of the above decision for communicating the same to the Cabinet Secretariat on a monthly basis.

3. KVS is also advised to obtain the approval of its Board of Governors for the proposals which have been listed as feasible but are yet to be approved by BOG including those cases mentioned in Annexure-II, feasibility of which is yet to be established.

4. KVS may pursue the matter with the sponsoring authorities setting a time frame of 3 months (say upto 30th June, 2017) for completion of all the prerequisites as per the norms of KVS for opening of the new KVs and utilize the sanctions on first - cum- first served basis in respect of the cases mentioned in the Annexures - I & II.
